1 Plaintiffs' Notice of Motion and Motion for Class Certification was submitted on July 27,
2 2018 and requested, *inter alia*, that Constantine Cannon LLP be appointed Lead Class Counsel and
3 The Mehdi Firm, PC be appointed Co-Lead Class Counsel, pursuant to Fed. R. Civ. P. 23(g). *Class*
4 *Motion* [ECF No. 379] at p. ii. This Court issued its Order granting, in part, plaintiffs' motion on
5 August 31, 2019. *See Class Order* [ECF No. 698]. The Court granted certification of a Rule
6 23(b)(2) class. The Court further found that plaintiffs have retained class counsel with experience in
7 litigating antitrust class actions, are willing to vigorously prosecute the action, and thus have
8 satisfied that component of Rule 23(a)(4)'s adequacy requirement. *Class Order* at p. 33.

9 **IT IS THEREFORE SO ORDERED THAT:**

10 Constantine Cannon LLP is hereby appointed as Lead Class Counsel and The Mehdi Firm,
11 PC, is hereby appointed as Co-Lead Class Counsel.
